
THE FACTS ABOUT FENTANYL

- Fentanyl is a highly addictive synthetic opioid that is 50 times more potent than heroin and 100 times more potent than morphine.
- Just two milligrams of fentanyl (the small amount that fits on the tip of a pencil) is considered a potentially deadly dose.
- According to the CDC, 107,622 Americans died of drug poisoning in 2021, with 75% of those deaths involving synthetic opioids like fentanyl.
- In 2022, fentanyl was responsible for 200 deaths every day. Over a quarter of a million Americans have died from a fentanyl overdose since 2018.
- Fentanyl is involved in more deaths of people under 50 than any other cause even heart disease, cancer, homicide, and suicide.
- In the past two years, the number of teenage overdose fatalities associated with opioids such as fentanyl has tripled.



Percent of opioid overdose deaths from synthetic opioids (mostly fentanyl), 1999 - 2021



While fentanyl is extremely potent, not every exposure or use leads to death. The risk of overdose increases significantly when it is used inappropriately or mixed with other substances.

DRUG TESTS CAN EASILY DETECT FENTANYL

While standard drug tests are effective for detecting certain substances, they may not reliably identify trace amounts of fentanyl. Fentanyl requires specific testing methods, and relying solely on multi-drug tests or testing strips designed for general opioid detection can lead to inaccuracies.

FENTANYL IS ONLY A PROBLEM FOR ILLICIT DRUG USERS

Fentanyl can also be encountered unintentionally, such as in counterfeit medications, through everyday vapes or when mixed with other drugs. It poses a risk to individuals who may not be aware of its presence, emphasizing the need for caution across various substances.

CASUAL CONTACT WITH FENTANYL CONTAMINATED SURFACES CAN EASILY LEAD TO OVERDOSE

The risk of overdosing on fentanyl through touching a contaminated object is extremely low. Harmful exposure usually requires direct ingestion, inhalation, or injection, dispelling the notion of a significant overdose risk from casual contact.
